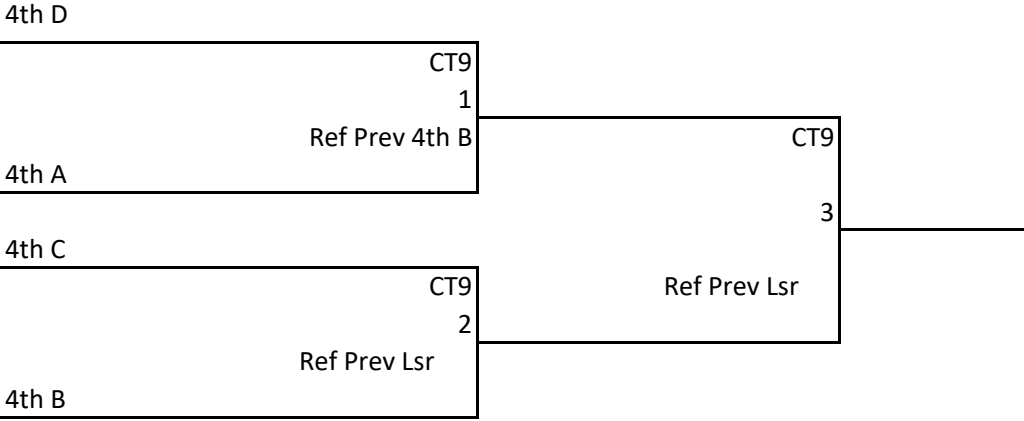
# 16's Silver Bracket

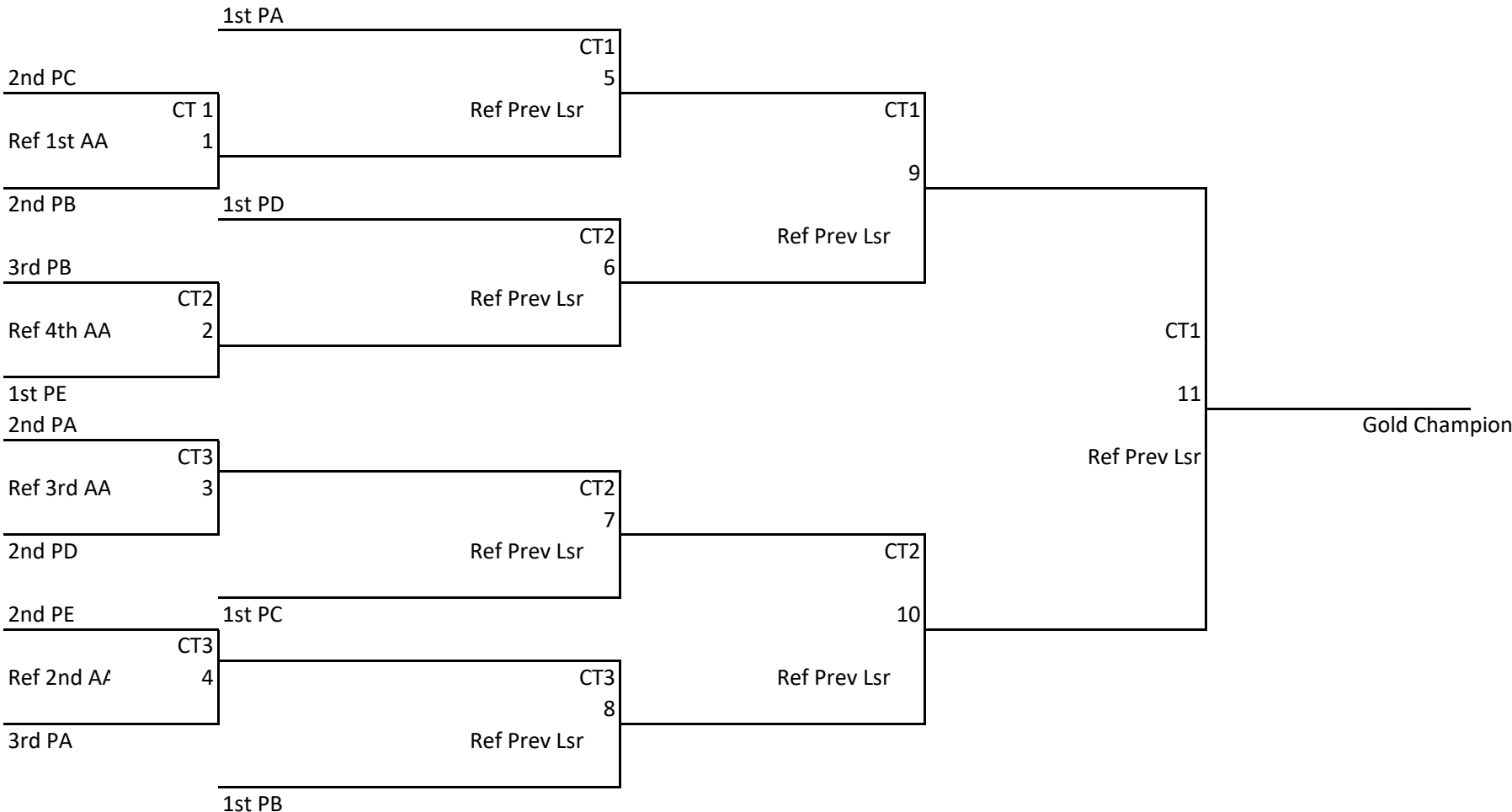
